

HOW TO READ YOUR **CON EDISON BILL** AS A WESTCHESTER POWER CUSTOMER

#1 ESCO electricity supply charges:

Better known as "supply charges." The total amount charged for the electricity through the Westchester Power program.

#2 Con Edison electricity charges:

Better known as "delivery charges." The total amount charged by the utility (ConEd) for the use of its lines to deliver electricity to your premise.

#3 Your electricity charges (Your delivery charges + Total delivery charges):

This is the breakdown and total amount of delivery charges from the utility, including taxes and surcharges. This is called "electricity charges" on page one, and is better known as "delivery charges."

#4 Your supply charges:

This is called "ESCO electricity supply charges" on the first page and is further described in the section titled "Your electricity supply detail" on the following page.

#5 Graph:

This is a chart showing your monthly electricity usage over the past year. For your current billing cycle, it compares your energy usage for the month with last year's energy usage for that same month.

#6 Your electricity supplier:

This is the energy supplier selected by our program, Westchester Power.

#7 Supply cost (cents per kWh):

This is the total cost of your electricity supply, which includes the fixed rate in cents per kWh and the taxes required by New York State.

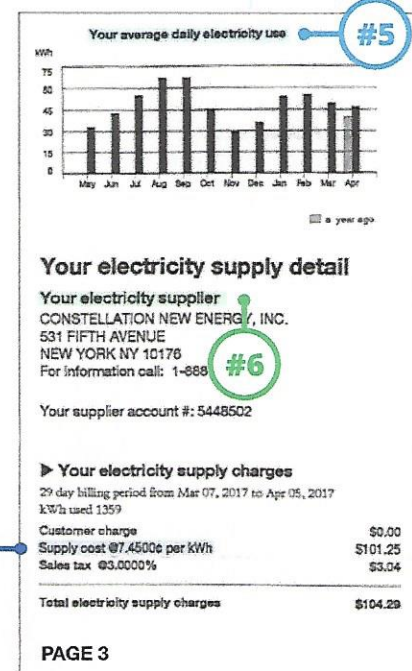
